

These terms and conditions must be read carefully by all involved before making a booking.

1. Passengers understand that participation in water sports and activities such as fishing, diving, boating is your decision and your own risk. Full personal travel insurance are advised for all passengers.
2. The captain is responsible for assuring that all passengers on board are fit and well complete the plan itinerary and activity. However in the interests of safety Sunnav reserves the right to change the planned itinerary. Sunnav has the right to cancel any trip due to the weather conditions or natural disaster at the last minute.
3. The captain reserves the right to refuse the participation of any passenger who is deemed to be of the poor health at the time of departure. Clients with special medical treatment must make aware to the sales team at the time of booking: failure to do this may result in passengers being denied permission to board the yacht.
4. The captain reserve the right to stop the trip at any stage if it is deemed that a passenger is under the influence do drugs or is over intoxicated with alcohol that she/ he could endanger the lives of themselves or other passengers. Drugs, illegal substances and hazardous goods in the yacht by passenger are strictly prohibited.
5. Dogs and other animals are not allowed on yacht.
6. Smoking is not allowed in the room for security reasons and respect for the non smoking passengers.
7. Passenger may not move furnishings, or interfere with the electrical network or any other installations in the yacht without the consent of the captain.
8. For security reasons, it is not appropriate to leave children under 10 years of age without adult supervision.
9. Complaints by guests and any possible suggestions for improving the yacht's activities are welcomed by the yacht management.
10. Passengers are obliged to observe the provisions of these Yacht Rules. In the event that a passenger is in breach of these rules, the Captain has the right to repudiate the agreement on the provision of services before the agreed period has elapsed.

11. Payment terms

- The payment terms are as follows: 30% deposit at the time of booking to confirm date Remaining 70% payment is due 1 week prior to departure date. If this final payment is not met, Sunnav has the right to cancel the booking and hold the deposit.

- Transportation transfer is not included in the price quotation : please advise in advance for arrange to serve the best.
- The number of guests should be confirmed before trip. Extra guests will be extra charged per person regarding to terms and conditions.
- Guests are obliged to pay for national park's entrance fees, kayak or sea canoe fee and other extra personal expenses.
- Passengers are to use the yacht for the agreed period. If the period of yacht is not stipulated in advance, passengers will to pay extra charge for 10,000 baht per hour.

12. Cancellations

Cancellation charges are as follows:

Within 1 week prior to departure date – 100% charter fee

- If the weather is deemed unsafe, then an alternate date will be offered or a full refund provided.
- If the Sunnav are unable to provide you with the services agreed and have to cancel your booking you can either
 1. Accept our offer of another vessel of the same or higher standard (subject to availability)
 2. Accept a full refund of money you have paid.

No compensation will be paid in the case of the unforeseeable and unusual circumstances beyond our control, the consequences of which could not have been avoided such as unavoidable technical problems with transport, war, fire and adverse weather conditions.
